

Official Rules
“Cinco de Mayo Kiosk Game”
May 5, 2026

A. Participant Eligibility:

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Participants must be a Potawatomi Rewards member; membership is free.
- iii. Participants must be on premises and earned required tier credits to be eligible to participate in the promotion.
- iv. Persons who are on PCHC’s list of banned patrons are not eligible to enter.
- v. Employees of PCHC, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCHC Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as an employee.

B. Agreement to Official Rules:

- i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCHC, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. The promotion period is May 5, 2026 at 9:00 am Central Time (CT)
- ii. The promotion end date May 5, 2026 at 11:59 pm Central Time (CT)
- iii. PCHC’s computer is the official time-keeping device for this promotion.

D. How To Enter: Eligible guests may participate in the promotion in the following way:

- i. Eligible Potawatomi Reward members can earn 500 tier credits to participate. Guests must swipe their Players Club card into any promotional kiosk, enter pin number, and select the appropriate Promotion tile. Game is available from 9 a.m. to 11:59 p.m. during the Promotion Period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

E. Free Entry:

- i. No free entry as this is a point redemption program.

F. Prizes:

- i. \$10 Reward Play, \$15 Reward Play, \$20 Reward Play, \$25 Reward Play, \$50 Reward Play, \$100 Reward Play, \$250 Reward Play, \$500 Reward Play, \$1000 Reward Play
- ii. Total estimate value of this promotion is \$9,355.

G. Rules & Notification:

- i. Guests can play the Cinco de Mayo Kiosk Game and win Reward Play during the Promotion Period after earning 500 same-day tier credits on their club card. Game must be played the same day as credits earned.

- ii. PCHC has the sole authority to determine the winners and such decisions are final. After earning 500 same-day tier credits, guests can go to any Promotional Kiosk, swipe their card, put in their pin number, select Monthly Promotions then touch Cinco de Mayo Kiosk Game and have a chance to win Reward Play. Cannot be combined with any other offers or promotions.
- iii. Reward Play from the kiosk game is valid for 24 hours after redemption.
- iv. ***Management has the right to alter or cancel a promotion at any time.***

H. Prize Acceptance/Restrictions:

- i. Guests must comply with all terms and conditions of these Official Rules.
- ii. The guest will be required to provide non-expired, government issued photo identification and a Potawatomi Rewards card to claim prize.

I. Release/Publicity/Use of Personal Information:

- i. Guests may be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

J. General Conditions:

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCHC reserves all rights, in its sole discretion, may:
 1. Suspend the promotional event to address the impairment and then resume the promotional event in a manner that best conforms to the spirit of these Official Rules.
 2. Cancel the promotional event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCHC reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCHC reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCHC's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

K. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCHC, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the promotion
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines



- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages
