Official Rules

1. Eligibility.

Tuesday Tier Kiosk Game is open to Ignite, Blaze and Flame Players Club members 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Promotion is valid at the Milwaukee Location only.

The Promotion period starts at 9:00 a.m. Central Time (CT), and ends at 11:59 p.m. CT each Tuesday in July, August and September:

- Tuesday, July 1st, 8th, 15th, 22nd & 29th, 2025
- Tuesday, August 5th, 12th, 19th & 26th, 2025
- Tuesday, September 2nd, 9th, 16th, 23rd & 30th, 2025

PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

All Ignite, Blaze and Flame Players Club card members may play the Tuesday Tier Kiosk Game. After earning 500 tier credits, guests must swipe their Players Club card into any promotional kiosk, enter their pin number, select Monthly Promotions and then touch "Tuesday Tier". Guests can participate once each Tuesday. Tuesday Tier is available from 9 a.m. to 11:59 p.m. on Tuesdays in July, August and September. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Eligible guests that sign up for a Players Club card will be eligible to participate that same day.

Earn Entries: All Ignite, Blaze and Flame Players Club card members who earn 500 tier credits or more on Tuesdays can swipe at the Kiosk and play the wheel spin game to receive a Reward Play offer. Guests can spin the wheel once each Tuesday from the points earned that day.

6. Drawing and Notification.

Must be present to win.

After earning 500 tier credits on their club card; guests can play the Tuesday Tier Kiosk Game and win Reward Play. Guests can participate and spin the wheel once each Tuesday for every 500 tier credits earned that day. The Tuesday Tier kiosk game will be available from 9:00 a.m. to 11:59 p.m. Guests can go to any promotional kiosk, swipe their card, put in their pin number, select Monthly Promotions and then touch "Tuesday Tier". Points can be earned starting at 9:00 a.m. and the game is only available from 9:00 a.m. to 11:59 p.m. The kiosk game must be played the same day as points earned. Reward Play is good for 7 days after redemption. PCH has the sole authority to determine the winners and such decisions are final.

9. Release, Publicity, Use of Personal Information.

10. General Conditions.

PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**
