Official Rules

1. Eligibility.

Labor Day Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Kiosk Promotional Period starts at 6 a.m. (CT), and ends at 11:59 p.m. (CT) on September 2nd, 2024. PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee location only.

Players Club card members can play the Labor Day Kiosk Game after earning 500 same-day base points, on September 2nd, 2024. To activate Reward Play, guests must swipe their Players Club card into any promotional kiosk, enter pin number, and select the appropriate Promotion tile. Labor Day Kiosk Game is available 6 a.m. to 11:59 p.m. during the Promotion period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

Exclusions: Live Poker is excluded from earning points toward this promotion.

6. Drawing and Notification.

Guests can play the Labor Day Kiosk Game and win Reward Play during the Promotion Period after earning 500 same-day base points on their club card. Game must be played the same day as points earned. PCH has the sole authority to determine the winners and such decisions are final. After earning 500 same-day base points, guests can go to any Promotional Kiosk, swipe their card, put in their pin number, select Monthly Promotions then touch Labor Day Kiosk Game and have a chance to win Reward Play. Guests can play once each day during the promotion. Reward Play from the kiosk game is good for 7 days after redemption.

Winner must present a valid ID and Players Club card to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport or state ID card.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners may be required to provide valid picture identification and a Players Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**

Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
