Official Rules

1. Eligibility.

Single Ticket Tuesdays is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Tuesday Drawings is valid at the Milwaukee location only.

- Select the Promotions Tile and enter their PIN
- Locate the appropriate Drawing Tile for that day within one (1) hour of the drawing.
- Press Tile to activate entries.

How it Works:

- Must be Present to win
- Winners will be announced over the PA system in the Casino. Announcements will be heard on the gaming floor only; announcements may not be heard in other areas such as Bingo, restaurants, etc.

PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
