Official Rules

1. Eligibility.

\$20K Halloween Drawing is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel ("PCH") and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

\$20K Halloween Drawing is valid at the Milwaukee location only.

The Promotion period starts at 12:00 a.m. Central Time (CT), October 31st, 2025 and ends at 7:00 p.m. CT, October 31st, 2025 (the "Promotion Period"). PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

- All winners who have a Players Club card receive one entry.
- Activate Entries: To activate their entry for electronic drawings: swipe Players Club card into any promotional kiosk, enter PIN and select promotions tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Winners may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

Must be present to win. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

5. Free Entry.

All Players Card members receive one free entry.

6. Drawing and Notification.

- 10 Winners each hour
- 5pm, 6pm, 7pm

How it Works:

- Winners will be announced throughout the Casino
- Winners must be present to win
- Winners will have 10 minutes to come to Promotions; after that the time frame will be reduced to 5 minutes.
- In the order their names were called, winners will pick one prize from each container starting with container #1 then moving forward in numerical order through container #5 or until they receive the "Cash Out Now" prize. If they receive the "Cash Out Now" prize, the game ends for this winner. If the guest receives the "Pick Again" prize, they choose another prize from the same container.
- When the guest either reaches the last container or the "Cash Out Now", the total Reward Play of each prize they won is totaled up and is applied to their account.
- Winners can start activating their entries at 4pm on Friday, October 31st and they must reactivate between each drawing.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Management reserves all rights to change or cancel this promotion at any time without notice.
