Thanksgiving Kiosk Game November 2025 Milwaukee Location Official Rules

1. Eligibility.

Thanksgiving Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Kiosk Promotional Period starts at 9 a.m. Central Time (CT) and ends at 11:59 p.m. (CT) on November 27th, 2025. PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee location only.

Players Club card members can play the Thanksgiving Kiosk Game after earning 500 tier credits, on November 27th, 2025. To activate Reward Play, guests must swipe their Players Club card into any promotional kiosk, enter pin, and select the appropriate Promotion tile. Thanksgiving Kiosk Game is available 9 a.m. to 11:59 p.m. during the Promotion period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.

6. Drawing and Notification.

Guests can play the Thanksgiving Kiosk Game and win Reward Play during the Promotion Period after earning 500 tier credits on their club card. Game must be played the same day as points earned. PCH has the sole authority to determine the winners and such decisions are final. After earning 500 tier credits, guests can go to any Promotional Kiosk, swipe their card, put in their pin, select Monthly Promotions then touch Thanksgiving Kiosk Game and have a chance to win Reward Play. Guests can play once each day during the promotion. Reward Play from the kiosk game is valid for 7 days after redemption.
