Official Rules

1. Eligibility.

Rock-Paper-Scissors is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel ("PCH") and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Rock-Paper-Scissors is valid at the Milwaukee Location only.

The Promotion period starts at 12:00 a.m. Central Time (CT), January 1st, 2026, and ends at 8:00 p.m. CT, January 29th, 2026. PCH's computer is the official time-keeping device for this Promotion.

4. How to Enter.

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive entries for every 100 tier credits earned on their club card starting at midnight January 1st through 8:00 p.m. on January 29th, 2026.

- **Activate Entries for electronic drawings:**

Kiosk Activation

- Club Card Members must swipe their Players card into any promotional kiosk.
- Select the Promotions Tile and enter their PIN
- Locate the appropriate Drawing Tile for that day within one (1) hour of the drawing.
- Press Tile to activate entries.

Slot Machine Activation:

How it Works:

- Winners will be announced throughout the Casino on the gaming floor only; announcements may not be heard in other areas such as Bingo, restaurants, etc.
- Check-in required
- Winners will have 10 minutes to come to the Promotions Stage; after that, the redraw time frame will be reduced to 5 minutes
- After checking-in winners will assemble in front of the stage
- Winners will Team-up in the order their names were called. (4 Teams total)
- Each Team will play 3 (GSA Reel Rounds) of Rock, Paper, Scissors on the Game Board to determine who will advance to the next Round.
- Game consists of a Rolling Wheel that guests will stop by pressing their button.
- Rock-Paper-Scissors Rules:
 - Rock crushes Scissors
 - Scissors cuts Paper
 - Paper covers Rock

If both players reveal the same sign – a tie results and must be replayed until there is 1 winner.

4 Players

2 eliminated players receive \$1,000 Reward Play

2 move-on to the final round

- **Round 3 (final round)**

2 Players

1 eliminated player receives \$2,500 Reward Play

1 winner receives \$7,500 Cash or Reward Play

- Reward Play under \$5,000 is valid for 7 days - \$5,000 & over valid 30 days
- Guests can win multiple times but only once per hour
- Entries carry over from week to week
- Guests can start activating their entries at 4 p.m. on drawing days; then they must reactivate between each drawing.

PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
