Official Rules

1. Eligibility.

\$300K Season Finale is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

The Promotion period starts at 12:00 a.m. Central Time (CT), April 1st 2025 and ends at 8p.m. CT, June 27th 2025. PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

Promotion is valid at the Milwaukee location only.

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive entries for every 100 tier points earned on their club card starting at midnight April 1st through 8pm on June 27th 2025.

- **Activate Entries:** To activate entries for electronic drawings swipe Players Club card into any promotional kiosk, enter PIN and select promotions tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

***Must be present to win. No mechanically reproduced entries will be permitted.

- 8:30 – 9pm upon successful hourly tournament play
