Official Rules

1. Eligibility.

April Fools' Day Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, ("PCH"). Employees of ("PCH") are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Promotion is valid at Milwaukee Location only.

The Promotion period starts at 9:00 a.m. Central Time (CT) on April 1st, 2026, and ends at 11:59 p.m. (CT) on April 1st, 2026. Guests can participate in the April Fools 'Day Kiosk Game only once during the promotional period.

PCH's computer is the official time-keeping device for this Promotion.

All Players Club card members may play the **April Fools' Day Kiosk Game**, after earning 500 same-day tier credits during the hours from 9:00 a.m. and 11:59 p.m. Guests must swipe their Players Club card into any promotional kiosk, enter pin, and select the appropriate Promotion tile. Game is available from 9:00 a.m. to 11:59 p.m. during the Promotion Period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Guests may play only once per promotional period.

Guests must be present to win. To activate guests can go to any Promotional Kiosk, swipe their card, put in their pin, select Monthly Promotions then touch “April Fools’ Day”. PCH has the sole authority to determine the winners and such decisions are final.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The Winner must present a valid ID and Players Club card to claim prize. Prizes are not transferable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted or fails to sign the required documents within the required time period, they forfeit prize.

9. Release, Publicity, Use of Personal Information.
