Official Rules

1. Eligibility.

Tuesdays Slot Tournament is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Tuesdays Slot Tournament is valid at the Milwaukee Location only.

The Promotion period starts at 12:00 p.m. Central Time (CT), August 4th, 2026, and ends at 6:00 p.m. CT, August 25th, 2026.

PCH’s computer is the official time-keeping device for this Promotion

4. How to Enter.

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive 1 entry for every 500 tier credits earned on their club card starting at 9:00 a.m. on August 4th through 6:00 p.m. on August 25th, 2026.
- After earning 500 same-day tier credits, guest must print out a ticket from the Promotional Kiosk to show at Promotions booth to be registered for a slot tournament.
- Guest can only play the slot tournament once per week.

***Must be present to win. No mechanically reproduced entries will be permitted.
All entries become the property of PCH and will not be returned.***

- Guests will compete in the Slot Tournament to determine their prize.
- Overall standings will be displayed at the Promotions stage after the 6pm tournament results.
- Reward Play will automatically be loaded on to players’ cards
- In the event of a tie, both prizes will be added up and split evenly among the tied winners
- Reward Play is valid for 168 hours (7 days) starting from the time of application. No reissuance of expired Reward Play will be allowed.
- Guests can participate only once per week
- Odds of winning a Slot Tournament are score-based; awarding prizes to the highest scores as defined in the overall standings. PCH has the sole authority to determine the winners and such decisions are final

8. Prize Acceptance/Restrictions.

Winners must provide a valid ID and a Players Club card to claim prize. Prizes are not transferable or assignable. No substitution is allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
