Official Rules

1. Eligibility.

Club 50 Senior Day Kiosk Game is open to those fifty (50) years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Promotion is valid at the Milwaukee Location only.

The Promotion period starts at 9:00 a.m. Central Time (CT), and ends at 11:59 p.m. (CT) each Wednesday during the months of July, August & September, 2026.

4. How to Enter.

All Players Club members fifty (50) years or older may play the **Club 50 Senior Day Kiosk Game**, after earning 200 same-day tier credits during the hours from 9:00 a.m. and 11:59 p.m., guests can then swipe their Players Club card into any promotional kiosk, enter their PIN, select Monthly Promotions and then touch “Club 50”. Guests can participate up to 5 times each Wednesday. The Club 50 Senior Day Kiosk Game is available from 9 a.m. to 11:59 p.m. each Wednesday. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Eligible guests that sign up for a Players Club card will be eligible to participate that same day.

The Club 50 Senior Day Kiosk Game will be available from 9:00 a.m. to 11:59 p.m. Guests can go to any promotional kiosk, swipe their card, enter their PIN, select Monthly Promotions and then touch “Club 50”. Reward Play is valid for 24 hours after redemption. PCH has the sole authority to determine the winners and such decisions are final.

Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law.
