### \$300K Enchanted Spins

#### 1. Eligibility.

**\$300K Enchanted Spins** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

#### 2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

#### 3. Promotion Period.

The Promotion period starts at 12 a.m. Central Time (CT), April 1<sup>st</sup>, 2025 and ends at 8:00p.m. Central Time (CT) April 24<sup>th</sup>, 2025.

Drawing Dates: Each Thursday in April; 3<sup>rd</sup>, 10<sup>th</sup>, 17<sup>th</sup> & 24<sup>th</sup>, 2025.

(The “Promotion Period”). PCH computer is the official time-keeping device for this Promotion.

#### 4. How to Enter.

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive entries for every 100 tier points earned on their club card starting at midnight April 1<sup>st</sup> through 8pm April 24<sup>th</sup> 2025.
- **3x entries on drawing days**
- **Activate Entries:** To activate entries for electronic drawings swipe the Players Club card into any promotional kiosk, enter pin number and select the Promotion tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

***Must be present to participate. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.***

#### 5. Free Entries.

No purchase necessary. Void where prohibited. Any Players Club member may obtain their free entries into each of the drawings based on club tier by swiping their club card at any Promotional Kiosk. Enter pin number and select the promotions tab, and then locate the appropriate promotion for the free entry.

**How it Works:**

- Winners will have 10 minutes to check-in with Promotions, after that the time frame will be cut to 5 minutes
- After checking in, winners will assemble by the promotion's booth / Enchanted Spins area
- Winners will compete in the Enchanted Spins to determine their prize.
- All Reward Play is valid for 7 days
- Guests can win multiple times but only once per hour
- Guests must be present to win

- Entries carry over from week to week
- Guests can start activating their entries at 4PM on Thursdays; then must reactivate between each drawing
- In the event of a mechanical issue/error, the Promotion's team will continue the drawing by having the winners choose envelopes in order to determine their prizes.
- Winners will be announced over PA system in Casino. Announcement is heard on gaming floor only; announcements may not be heard in other areas such as Bingo, restaurants, etc.
- Odds of winning a drawing depend on the number of eligible entries received. PCH has the sole authority to determine the winners and such decisions are final
- In the event of a tie, players must compete one-on-one to determine the prize outcome.

  - Players ranking in places 6<sup>th</sup>-4<sup>th</sup> receive \$1,000 Cash
  - Players ranking in places 3<sup>rd</sup>-2<sup>nd</sup> receive \$2,000 Cash
  - Player who ranks 1<sup>st</sup> receives \$5,000 Cash
    - In the event of a tie, the players will play against each other to determine their appropriate prize

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The winners must be required to provide valid picture identification and a Players Club card to claim prize. Prizes are not transferrable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.

## 8. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of his/her name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

## 9. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

## 10. Limitations of Liability and Release.

Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
