Official Rules

1. Eligibility.

Sunday Spins is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, (“PCH”). Employees of (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Sunday Spins is valid at the Milwaukee Location only.

The Promotion period starts at 09:00 a.m. Central Time (CT), July 5th, 2026, and ends at 5:00 p.m. CT, September 30th, 2026.

4. How to Enter.

Kiosk Game:

Players Club card members may play the **Sunday Spins**, after earning 500 same-day tier credits between the hours of 9:00 a.m. and 11:59 p.m. each Sunday during the promotion period above. Guests must swipe their Players Club card into any promotional kiosk, enter their PIN, and select the

appropriate Promotion tile. The Kiosk Game is available from 9:00 a.m. to 11:59 p.m. each Sunday during the promotion period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Guests may play once each Sunday during the promotion period listed above.

- **Earn Entries:** Guests will receive one (1) entry for the first 500 Same-day tier credits earned each Sunday with their club card from 9:00 a.m. until 11:59 p.m. during the promotion period above.

- Club Card Members must swipe their Players card into any promotional kiosk.
- Select the Promotions Tile and enter their PIN
- Locate the appropriate Drawing Tile for that day within one (1) hour of the drawing.
- Press Tile to activate entries.

Slot Machine Activation:

- Insert Players card into any slot machine
- Place a minimum bet
- Remove club card

How it Works:

- Winners will be announced over the PA system in the Casino.
- Announcements will be heard on the gaming floor only; announcements may not be heard in other areas such as Bingo, restaurants, etc.
- Winners will have 10 minutes to check-in with Promotions, after that the time-frame will be cut to 5 minutes.
- Drawing Reward Play is valid for 72 hours (3 days) starting from the time of application. No reissuance of expired Reward Play will be allowed.
- All Kiosk Reward Play Prizes are valid for 24 hours
- Guests can win multiple times but only once per hour during the Finale Drawing
- Entries carry over from week to week.
- Guests can start activating their entries at 2pm on Wednesday, September 30th, 2026; then must reactivate between each drawing.
- Guest receive 1 entry for every Sunday they participate in the Kiosk Game
- Odds of winning a drawing depend on the number of eligible entries received. PCH has the sole authority to determine the winners and such decisions are final

7. Drawing and Notification

Guest can play “Sunday Spins” once after earning 500 same-day tier credits on their club card every Sunday in July, August & September, 2026 between 9:00 a.m. - 11:59 p.m. Game must be played the same day tier credits are earned.

To activate drawing entries, guests can go to any Promotional Kiosk, swipe their card, put in their pin, select Monthly Promotions then touch Sunday Spins. Guests must be present to win. PCH has the sole authority to determine the winners and such decisions are final.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. Winners must provide a valid ID and a Players Club card to claim prize. Prizes are not transferable or assignable. No substitution is allowed except by PCH,

who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of their name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**
