**1. Eligibility.**

**\$300K Boundless Bounty Game Show** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel (“PCH”) and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

**2. Agreement to Official Rules.**

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

**3. Promotion Period.**

The Promotion period starts at 12 a.m. Central Time (CT), June 1<sup>st</sup>, 2025 and ends at 8:00 p.m. Central Time (CT) June 26<sup>th</sup>, 2025.

Drawing Dates: Thursdays; June 5 – 12 – 19 – 26, 2025

(The “Promotion Period”). PCH computer is the official time-keeping device for this Promotion.

**4. How to Enter.**

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive entries for every 100 tier credits earned on their club card starting at midnight June 1<sup>st</sup> through 8 p.m. June 26<sup>th</sup>, 2025.
- **3x entries on drawing days**
- **Activate Entries:** To activate entries for electronic drawings swipe the Players Club card into any promotional kiosk, enter pin number and select the Promotion tile. Locate the appropriate drawing for that day within one (1) hour of the drawing to activate entries. Guests may also activate their entries at any slot machine. Insert Players Club card into any slot machine, place a minimum bet, then remove club card.

*Must be present to participate. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned.*

**5. Free Entries.**

No purchase necessary. Void where prohibited. Any Players Club member can obtain their free entries into each of the drawings based on club tier by swiping their club card at any Promotional Kiosk. Enter pin number and select the promotions tab, and then locate the appropriate promotion for the free entry.

**Potential Prize Payouts**

**Payout 1:**

- 1 Boundless Bounty Winner- Highest Score - \$11,500 (Cash or Reward Play option)
- 2 Boundless Bounty Winners - \$1,000 Reward Play

**Payout 2:**

- 2 Boundless Bounty Winners – Tie Highest Score – split \$12,500 (\$6,250 Cash or \$6,250 Reward Play option)
- 1 Boundless Bounty Winner - \$1,000 Reward Play

**Payout 3:**

- 3 Boundless Bounty Winners -Tie Scores – split \$13,500 (\$4,500 Cash or Reward Play option)

**How it Works:**

- Check-in required
- Winners will be announced over the loud speaker.
- Winners will have 10 minutes to check-in with Promotions, after that the time frame will be cut to 5 minutes
- After checking in, winners will assemble in the order their name was called
- Winners will select envelopes to determine whether they get to play the Game Show
- Eliminated guests receive Reward Play
- All Reward Play is valid for 7 days
- Guests can win multiple times but only once per hour
- Entries carry over from week to week
- Guests can start activating their entries at 4PM on Thursdays; then must reactivate between each drawing

## Game Rules

- “Boundless Bounty” Roulette Revolution is a three-player game. The casino sets the number of total turns for all three players. The default is 5 turns.
- Player 1 highlights and verbally selects RED or BLACK.
- Once the selection is locked in, the operator starts the wheel spinning.
- The wheel consists of 12 segments, alternating red and black wedges.
- Once the wheel starts spinning, the player can drop the ball in play by hitting a buzzer.
- The ball drops into play and bounces around the wheel, after a few seconds, the wheel slows to a stop, with the ball settling on a segment at the bottom of the wheel.
- If the player is correct, that player gets a point.
- If the player is incorrect, the player does not get a point.
- Game play then moves to Player 2, where this process is repeated.
- After Player 2’s turn, game play moves to Player 3.
- Once all 3 players play, that “turn” is over and the next turn starts with Player 1.
- This process is repeated until Player 3 completes the final turn.
- After 5 number of turns for each player, the game is over.
- The player with the highest score wins the game, and wins a casino determined prize.
- The other two players would receive consolation prizes determined by the casino.
- It is possible for 2 players to win the game, where they split the grand prize 50/50.
- The other player would win a consolation prize.
- It is also possible for 3 players to win the game, where they split the grand prize 3 ways.
