Official Rules

1. Eligibility.

Monday Football Kiosk Game is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Potawatomi Bingo Casino and Potawatomi Hotel are separate business entities of the Forest County Potawatomi Community marketed together as Potawatomi Casino | Hotel, (“PCH”). Employees of (“PCH”) are not eligible to participate in the Promotion.

2. Agreement to Official Rules.

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

3. Promotion Period.

Promotion is valid at: Milwaukee Location only.

The Promotion period starts at 9:00 a.m. Central Time (CT) on October 6th, 2025, and ends at 11:59 p.m. (CT) on December 29th, 2025.

Guests can participate in the Monday Football Kiosk Game up to four (4) times per day on each of the following **Mondays**:

- **October** - 6th, 13th, 20th & 27th 2025
- **November** - 3rd, 10th, 17th & 24th 2025
- **December** - 1st, 8th, 15th, 22nd & 29th 2025

PCH’s computer is the official time-keeping device for this Promotion.

4. How to Enter.

All Players Club card members may play the **Monday Football Kiosk Game**, after earning 200 tier credits during the hours from 9:00 a.m. and 11:59 p.m. Guests must swipe their Players Club card into any promotional kiosk, enter their PIN, and select the appropriate Promotion tile. Game is available from 9:00 a.m. to 11:59 p.m. during the Promotion Period. No mechanically reproduced entries will be permitted. All entries become the property of PCH and will not be returned. Guests may play up to four (4) times each Monday during the promotional dates listed above.

Please note: The winners of any and all promotional prizes are responsible for any applicable taxes or fees. Winner must present a valid ID and Players Club card to claim prize. A valid ID includes any government-issued ID such as a driver’s license, passport, or state ID card.

7. Drawing and Notification.

How it Works:

- Guests can play the Monday Football Kiosk Game after earning 200 tier credits on their club card on Mondays in October, November & December; up to four (4) times each day during the promotional period between 9:00 a.m. - 11:59 p.m.
- Game must be played the same day tier credits are earned.
- Guests must be present to win.
- To activate; guests can go to any Promotional Kiosk, swipe their card, put in their PIN, select Monthly Promotions then touch Monday Football Kiosk Games.
- Guests can spin a wheel that will designate how many spaces a player can move down the field. “If they pass or land on a prize space, they will win various Reward Play Prize.”
- If they do not pass or land on a prize space, they will receive 5,000 Reward Points (Cash Value \$5.00).
- Guests will continue on their game board from where they left off on their previous visit.
- Game resets after they make a touchdown.
- Game also resets monthly.
- PCH has the sole authority to determine the winners and such decisions are final.

8. Prize Acceptance/Restrictions.

Potential winners must comply with all terms and conditions of these Official Rules. Winning is contingent upon fulfilling all requirements. The Winner must present a valid ID and Players Club card to claim prize. Prizes are not transferable or assignable. No substitution allowed except by PCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

9. Release, Publicity, Use of Personal Information.

Winners may be asked to allow use of their name and likeness for promotions/advertising purposes and announcements. If granted, an additional waiver, or Photo Release, will be filled out.

10. General Conditions.

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus or other technical problem, PCH may, in its sole discretion, either: (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Promotion and award the prizes in a random drawing from among all eligible entries received up to the time of impairment. PCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and should an attempt be made, PCH reserves the right to seek damages from any such person to the fullest extent of the law. PCH's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. **Management reserves all rights to change or cancel this promotion at any time without notice.**
