**Official Rules**

**1. Eligibility.**

**Bernie's Winning Streak** is open to those 21 years of age or older at the time of entry and must not be listed in the Potawatomi Casino | Hotel Banned Patron List. Must have a valid Players Club card to enter; membership is free. Employees of Potawatomi Casino | Hotel ("PCH") and the immediate family members of the Marketing Department, VIP Services and Upper Management Team which includes Directors, Assistant Directors, Chief Financial Officer, Assistant General Manager and General Manager are not eligible to participate in the Promotion. An immediate family member is defined as a parent, sibling, child, spouse or any other person residing in the same household as employee.

**2. Agreement to Official Rules.**

By participating in the Promotion, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of PCH, which are final and binding in all matters related to the promotion.

**3. Promotion Period.**

**Bernie's Winning Streak is valid at the Milwaukee Location only.**

**4. How to Enter.**

All guests who have a Players Club card may enter.

- **Earn Entries:** Guests can receive entries for every 100 tier credits earned on their club card starting at midnight June 1<sup>st</sup> through 8:00 p.m. on June 25<sup>th</sup>, 2026.

- **3x entries on drawing dates**

- **Activate Entries for electronic drawings:**

**Kiosk Activation**

- Club Card Members must swipe their Players card into any promotional kiosk.
- Select the Promotions Tile and enter their PIN
- Locate the appropriate Drawing Tile for that day within one (1) hour of the drawing.
- Press Tile to activate entries.

**Slot Machine Activation:**

- Insert Players card into any slot machine
- place a minimum bet

Announcements will be heard on the gaming floor only; announcements may not be heard in other areas such as Bingo, restaurants, etc.

- After checking in, winners will assemble in front of the stage
- Winners will pick an envelope in the order their names were called.
- Six will be eliminated - \$500 Reward Play

- **Bernie's Winball Game Play:** Each guest (4) will drop five balls into the Bernie's Winball game board attempting to land in buckets; worth different amount of points.
